THE PEGASUS TRIAL IN PEMPHIGUS VULGARIS (PV) AND PEMPHIGUS FOLIACEUS (PF) IS NOW ENROLLING



Principia Biopharma is conducting a Phase 3 clinical trial of an investigational drug (PRN1008, an oral pill). PRN1008 is a Bruton's tyrosine kinase (BTK) inhibitor which may improve pemphigus. This trial is being done to see if PRN1008 is safe and can achieve disease remission (clear skin with no blisters) with reduced corticosteroids.

The MDS is a physician organization dedicated to:

Target Audience and Symposium Description and Learning Objectives

Demonstrate knowledge about established and evolving biomedical, clinical and cognate sciences and their application in patient care. Investigate and evaluate patient care practices, appraise and assimilate scientific evidence and improve practice of medicine.

Identify errors and hazards in care; understand and implement basic safety design principles; continually understand and measure quality of care in terms of structure, process and outcomes in relation to patient and community needs; design and test interventions to change processes and systems of care with the objective of improving quality.

Communicate, manage knowledge, mitigate error, and support decision making using information technology.

This activity will provide educational content aimed at closing the defined gap to result in improved knowledge, competence, and/or performance, which could result in improved patient outcomes.

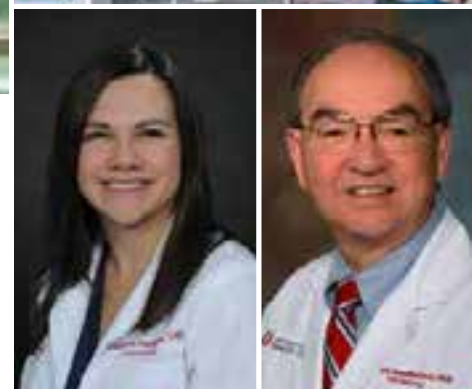

Cutaneous Oncology Fellowship which is a one-year program that provides specialized training in the diagnosis and management of cutaneous malignancies. It is targeted towards dermatologists who want to gain proficiency in the latest therapies and principles involved in the management of patients with a broad range of skin cancers including melanoma, cutaneous lymphomas, Merkel cell carcinoma, high risk basal and squamous cell cancers, and a number of rare malignancies. Program Director: Nicole LeBoeuf, MD, MPH.

Dermatology/Rheumatology Fellowship program. The Fellow will develop expertise in the diagnosis and management of a wide range of connective tissue diseases, including cutaneous lupus, dermatomyositis, scleroderma, psoriasis, and vasculitis. The program will include the full spectrum of clinical management, from learning unique physical exam skills to aid in clinical diagnosis to gaining familiarity with systemic therapeutics. A multi-disciplinary approach will be utilized, and the Fellow will work closely with both dermatologists and rheumatologists. The Fellow's career development will be a primary goal of the year-long fellowship. Opportunities for clinical and translational research as well as dedicated elective time will also be available to the Fellow. Program Director: Ruth Ann Vleugels, MD, MPH.
