NIH Clinical Research Study of **Anakinra for Inflammatory Pustular Dermatoses**

The National Institutes of Health (NIH) is investigating the safety and efficacy of anakinra for the treatment of inflammatory pustular dermatoses. Anakinra is a recombinant interleukin 1 receptor antagonist administered as a daily injection. Study drug, laboratory tests, and study procedures are provided at no cost to participants.

Eligible patients must be:

- Adults diagnosed with inflammatory pustular dermatoses including, but not limited to, generalized pustular psoriasis, palmoplantar pustulosis, acrodermatitis continua of Hallopeau and subcorneal pustular dermatosis.
- Able to travel to the NIH once monthly for 4 months. Travel may be reimbursed.

Study participants may receive:

- A physical exam of the skin, joints, eyes, and heart; blood work, urine analysis, skin biopsy, and imaging studies.

Further details about the study will be shared with the referring physician.
